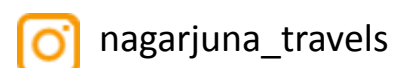
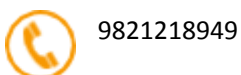

# Terms & Conditions for Adi Kailash & Om Parvat Yatra Organized by Nagarjuna Travels

By booking the **Adi Kailash & Om Parvat Yatra** with **Nagarjuna Travels**, you agree to abide by the following terms and conditions. Please read them carefully before confirming your participation.

## 1. Eligibility & Booking

- Participants must be **physically fit** for high-altitude travel. A medical check-up is recommended before booking.
- A **valid government-issued ID** is required at the time of booking. Foreign nationals must provide a passport and visa details.
- Booking is confirmed only after an **advance payment**, as per the payment schedule.

## 2. Travel Documents & Permits

- Indian nationals must carry an **Aadhar Card and Voter ID** for Inner Line Permit processing.
- Nagarjuna Travels assists in obtaining the necessary permits, but the approval of permits lies with the respective government authorities.

## 3. Health & Travel Insurance

- Travelers must ensure they are medically fit for the yatra, as it involves high-altitude regions with **limited medical facilities**.
- **Travel insurance covering high-altitude sickness, medical emergencies, and evacuation** is strongly recommended.
- Nagarjuna Travels is not liable for any medical emergencies, accidents, or health issues arising during the trip.

## 4. Itinerary & Route Changes

- The itinerary is subject to change due to **weather conditions, roadblocks, or administrative regulations**. Nagarjuna Travels reserves the right to modify or reschedule the tour if necessary.
- If the tour is disrupted due to **natural calamities (landslides, snowfall, floods, etc.)** or government restrictions, no refunds will be provided. However, the team will assist in making alternative arrangements.

## 5. Cancellation & Refund Policy

- If a traveler cancels after booking, the **refund policy** below will apply:

<b>Cancellation Time</b>	<b>Refund Percentage</b>
More than 45 days before departure	80% refund
30-44 days before departure	50% refund
15-29 days before departure	25% refund
Less than 15 days before departure	No refund

- If the **trip is canceled by Nagarjuna Travels** due to operational reasons, a full refund will be provided, excluding non-refundable costs (permits, accommodation bookings, etc.).
- If the yatra is canceled due to **government restrictions, natural disasters, or other unforeseen circumstances**, **no refund** will be provided.

## 6. Payment Terms

- A minimum **50% advance payment** is required to confirm the booking.
- The remaining **balance must be paid 35 days before departure**.
- Failure to make full payment within the due date may result in trip cancellation, and the advance amount will be forfeited as per the cancellation policy.

## 7. Code of Conduct & Safety

- Participants must **follow the instructions** of the tour guide and local authorities.
- Alcohol, drugs, and any unlawful activities are strictly prohibited during the tour.
- Travelers are responsible for their own belongings. Nagarjuna Travels is not liable for any **loss, theft, or damage** to personal property.

## 8. Acknowledgment of Risk

- The **Adi Kailash & Om Parvat Yatra** involves travel in remote, high-altitude regions. Travelers acknowledge that they are undertaking this journey at their own risk.
- Nagarjuna Travels is not responsible for any **injuries, altitude sickness, or medical emergencies** that may arise during the trip.
